#### MEMORANDUM OF UNDERSTANDING

# Between Oklahoma State Parks Rangers and The Oklahoma Department of Mental Health and Substance Abuse Services

## AGREEMENT TO PROVIDE OVERDOSE REVERSAL TRAINING & OVERDOSE REVERSAL KITS

This Agreement is entered into this 21st day of November, 2017, by the Oklahoma State Park Rangers (hereinafter referred to as "OSPR") and the Oklahoma Department of Mental Health and Substance Abuse Services (hereinafter referred to as "ODMHSAS").

#### Purpose and Objectives of Agreement/Project

This Agreement reflects the understanding of the OSPR and ODMHSAS regarding the ODMHSAS's sponsorship of an overdose reversal training course for OSPR and overdose reversal kits. This Agreement will:

- Build a working relationship between the organizations with a common goal of reducing the number of overdose deaths.
- Provide OSPR access to overdose reversal kits.
- Provide OSPR training in using overdose reversal kits.

#### Responsibilities of ODMHSAS

- 1.) Sponsor and conduct an overdose reversal training course for OSPR.
- 2.) Provide all necessary equipment for trainings as well as training materials.
- 3.) Provide OSPR appropriate forms for documenting the training of OSPR personnel in utilization of overdose reversal kits.
- 4.) Provide OSPR appropriate forms for documenting the utilization of each overdose reversal kit.

### Responsibilities of OSPR

- 1.) Train personnel in the proper use of overdose reversal kits.
- 2.) Provide overdose reversal kits for the training and future use by OSPR personnel.
- 3.) Document the training of personnel using forms provided by ODMHSAS and remit the completed forms to ODMHSAS for managing data.

- 4.) Use overdose reversal kits for their intended purposes.
- 5.) Document the utilization of each overdose reversal kit using forms provided by the ODMHSAS and remit the completed forms to ODMHSAS for managing data.
- 6.) Identify methods to coordinate the project in accordance with all relevant laws/rules and sustain the project in the event the ODMHSAS is unable to renew the agreement
