Description of Amendment:

a. This is to incorporate the following:

- Q1. Lake Texoma has always matched Lake Murray when it comes to number dumpsters, the dumpster sizes, and the days of pick-up; however, the pricing document show a change. Was this intentional a mistake?
A1. The information in the pricing sheet is accurate.
- Q2. When will discussions regarding pick-up days occur?
A2. This is information that will be discussed between the park manager and awarded supplier after contract award. The process currently must go through the bid period, the evaluation, and the contract award. Once the contract is awarded vendors will receive a Notice to Proceed (NTP) from the agency. Discussions regarding scheduling and dumpsters will be initiated by the park manager.
- Q3. On the bid sheet OTRD has Great Plains State Park listed. Is this to quote for renewal on June 30,2021?
A3. This is an entirely new contract that will supersede all outstanding agreements. This solicitation is not a renewal of any current service but an opportunity for all potential suppliers to bid on waste collection for the parks, lodges, and golf courses they can and want to service.
- Q4. If you have a current contract with the park is that contract not valid?
A4. The contract will remain valid until the effective date of the new contract. The effective date is the date the Notice to Proceed is issued to the vendor from the contracting officer.
- Q5. When will contract be awarded?
A5. There is no date for this contract to be awarded due to the evaluation and negotiation processes. These vary in duration depending on multiple factors some of which are the number bids received, the number of exceptions taken, the number of clarification questions asked, the amount of time it takes to receive



responses to clarification questions, etc. This stated, the goal is to have this completed by November 26, 2021.

Q6. Sequoyah Bay was not listed under the Sequoyah tab on the pricing sheet. Is it part of the solicitation?
A7. The pricing sheet has been updated to include Sequoyah Bay and Sequoyah State Park under the Sequoyah tab.

Language in Attachment B General Terms and Conditions 7.1.G shall change from "...later than six (6) months after the end of the fiscal year in which the goods are provided or services performed." to "...later than ninety (90) days after the goods are provided or services performed."

b. All other terms and conditions remain unchanged.
